Dear Minister,

My role at this meeting is to represent supporters of the issues raised in three petitions promoted by Save Our Trees. Two petitions were tabled in the Legislative Council in September 2006 and November 2008. The third petition is currently available for residents anywhere in Australia to present to their local or state authority. The issues raised in all three petitions cross a number of portfolios: Environment, Health, Local Government and Planning and Infrastructure.

The Save Our Trees network of residents began in the western suburbs of Perth in 2005 but now represents residents from suburbs throughout Western Australia. The residents are concerned about past and present government policies and practices that have placed at risk and continue to place at risk public health and the natural environment.

We are simply stating that we no longer accept the government rationale that countless mature living trees may be removed under tree replacement policies, and that vast areas of public land such as playgrounds, playing fields, verges, medians, parkland and bushland may be sprayed with various herbicides and pesticides.

We are aware that there are strong links between tree removal and climate change, diminished air, soil and water quality. Similarly, we are aware that there are strong links between herbicides / pesticides and human and animal ill health, as well as diminished soil and water quality. These issues are inextricably linked and must be addressed by all the relevant Ministers.

We ask that you and the relevant Ministers urgently rescind the policies and recommendations promoted in the National Weed Strategy and the Environmental Weed Strategy, Western Australia and all other such policies and recommendations in Local and state Governments. We believe that these policies and recommendations have led to the ongoing removal of living trees and the poisoning of public land for the killing of weeds in our suburbs. Both nationally and internationally there is concern about the chemical cocktail that exists in our soils and waterways. We call for these activities to stop in the interest of the natural environment and public health.
